Being a **100% APW-ABA local is a great organizing tool**. It is also a great low cost benefit for members and their families. The 100% local discount rate is 75 cents per member per pay period for the Value Plan and \$3.00 per member per pay period for the Advantage Plan. Those of you who are already 100% locals know the value of this membership oriented benefit and how great it is to be able to say "as a member of this local we have you covered".

The benefit for the Value Plan is \$12.00 per day for every day (up to 365 days per accident) of total disability due to a covered accident (up to \$4380.00 for a full year): And accidental death coverage of \$6000.00. The benefit for the Advantage Plan is \$24.00 per day for every day (up to 365 days per accident, \$8760.00) of total disability due to a covered accident: And accidental death coverage of \$10,000. Spouses can be added at the discounted rate for any/all members via dues check off, at the member's expense.
